## GENERAL TERMS AND CONDITIONS OF USE

### RECITAL

The access and the use of the Website are subject to these Terms and Conditions of Use as well as the applicable national and international laws and regulations.

The access to the Website and its use by the User imply unconditional acceptance by the latter of the Terms and Conditions of Use in their latest version.

The Service Providers reserve the right to modify and/or update, at any time and without prior notice, these Terms and Conditions of Use as well as the Content of the Website. These modifications and updates may eventually be subject to the express acceptance of a new version

of the Terms and Conditions of Use. Either way, all these modifications and updates are binding for the User at every connection to the Website.

## **ARTICLE 1: Definitions**

« Content »: means all the elements, in particular the functionalities and the information, provided by the Service Providers to the User and accessible through the Website.

« Service Providers »: means Automobiles Peugeot, Automobiles Citroën and Opel Automobile GmbH as defined in the legal notice. Automobiles Citroën is acting in the name and on behalf of DS Automobiles and Opel Automobile GmbH is acting in the name and on behalf of Vauxhall and Chevrolet (Europe).

« Terms and Conditions of Use »: means this document.

« User »: means any Independent Operator (\*), Testing Centre (\*\*), Assistance and First Aid (\*\*\*) and Other Professionals (\*\*\*\*) as defined below using the Website as part of their professional activity and for business purposes only. Consumers are expressly excluded from this definition of User.

(\*) « Independent Operator »: means a natural or legal person, other than an authorized dealer or repairer, which is directly or indirectly involved in the repair and maintenance of vehicles as defined in Regulation (EU) 2018/858 of the European Parliament and of the Council of 30 May 2018.

For Australia, “Independent Operator”: means any «Independent Repairer » (a) and «Registered Training Organization» (b) as defined in the « Competition and Consumer Amendment (Motor Vehicle Service and Repair Information Sharing Scheme) Act 2021: No.54, 2021».

(a) « Independent Repairer »: means a natural or legal person, other than an authorized dealer or repairer, which is directly involved in the repair and maintenance of vehicles

(b) «Registered Training Organization» A RTO is a registered training organization that provides, or seeks to provide, a course (a RTO course) in Australia providing training in diagnosing faults with, servicing, repairing, modifying or dismantling scheme vehicles.

(\*\*) « Testing Centre »: means a public or private body or establishment authorized by a Member State to carry out roadworthiness tests as defined in the Commission implementing Regulation (EU) 2019/621 of 17 April 2019.

(\*\*\*) « Assistance and First Aid »: means in particular fire services, police services and emergency services without this list being exhaustive.

(\*\*\*\*) « Other Professionals »: means in particular competent authorities and companies operating fleets of vehicles manufactured by the Service Providers, without this list being exhaustive.

« Website »: means the website accessible at the address <https://public.servicebox-parts.com> intended to the User accordingly to his profile and the regulations and laws in force in his country to access and/or order :

- technical information for:
  - o repair and maintenance;
  - o roadworthiness test;
  - o rescue;
- technical support for diagnostics and repair;
- diagnostic and repair single licence;
- technical training materials.

## **ARTICLE 2: Purpose**

The purpose of these Terms and Conditions of Use is to define the modalities and conditions of use of the Website and access to its Content by the User. The use of the Website and access to its Content are subject to the compliance with all these Terms and Conditions of Use by the User.

## **ARTICLE 3: Presentation of the Website**

### **3.1. Username and password**

To access to the functionalities offered by the Website, the User must first create a User account providing his full contact details to the Service Providers: title, surname, first name, email address, phone number, complete address with post code, town and country, company, SIRET number (France) or ABN (Australian Business **Number**) (Australia) and inter-community VAT code (for the member state of the European Economic Area).

To create a User account, the User has to follow the following steps:

1. First, the User goes on the home page of the Website.
2. Secondly, the User goes to the registration form and ticks the box corresponding to his activity. For example: a User that is a Testing Centre has to tick the box “Roadworthiness testing Center” to access to technical information for Roadworthiness tests.
3. Thirdly, the User completes his full contact details as presented above and chooses a password.
4. Fourthly, the User confirms his registration after accepting the Terms and Conditions of Use, the pricing conditions, the privacy policy and after confirming that he is not a robot.

5. Fifthly, the User receives a confirmation email containing his username and a link on which he has to click to connect for the first time on his User account and consequently to validate his registration.

Only one User account can be created per email address. The username and the password created by the User enables the User to access to the functionalities offered on the Website. To connect to his User account on the Website, the User has to input his username and his password.

The User must log off after every use of the Website.

The username and the password are strictly personal and the User undertakes to ensure that they remain confidential. Therefore, the User is liable for all use of his username and/or his password and under any circumstances the Service Providers may not be held liable for any loss of username and/or password and/or for any damage caused by their use by an Internet user who is not the User.

### **3.2. Functionalities offered by the Website**

Once the User has created an account on the Website and has login, he can access and/or purchase:

- Technical information for repair and maintenance:

The Users that are Independ Operator can purchase the access to technical information on the chosen Service Provider's vehicles, and in particular the specific tooling required for certain repairs, the information required to calculate labor times, the electrical wiring diagrams, without this list being limitative.

- Technical information for roadworthiness test information:

The Users that are Testing Centre, to the exclusion of all other categories of customer, can purchase the access to technical information for periodic roadworthiness tests of the vehicles of their clients.

- Technical information for rescue information:

The Users that are Assistance and First Aid can access to the help manual for rescue of passengers.

- Technical support for diagnostic and repair:

The user, in the event of difficulties encountered on the website when using technical information to perform diagnostic and / or repair services on a vehicle, can have access to technical support.

- Diagnostic and repair single licence:

The User can be granted, in exchange of a payment, a license (hereinafter referred to as the “Single License”) from the Service Providers for a chosen Service Provider’s vehicle identified in the Service Provider’s systems through its VIN number (Vehicle Identification Number). This Single License enables the User to use the diagnostic and repair software for the ECUs fitted on the Service Provider’s vehicles, as well as the diagnostic flow process grids and technical information for said vehicle for the purposes of completing repair and service operations on the said Manufacturer’s vehicle. This Single License is granted to the User by the Service Providers on a non- exclusive, non-assignable and non-transferable basis.

- Technical training material:

The User can access to training materials that aim to deliver a set of theoretical knowledge and techniques necessary to ensure the maintenance and repair of the chosen Service Provider’s vehicles.

Please note that, at the time to purchase and/or access to any functionality, the User chooses to which brand of the Service Providers he wants his subscription to be related. In other words, he chooses if he wants to access and/or to purchase a functionality branded Peugeot or Citroën or DS or Opel or Chevrolet.

#### **ARTICLE 4: Use of the Website by the User**

The User undertakes to comply with these Terms and Conditions of Use and guarantees the Service Providers against any illicit, fraudulent, non-compliant and/or non-authorized use of the Website and/or of its Content.

The User undertakes to use the Website and any service available through it in accordance with the applicable national and international laws and regulations.

#### **ARTICLE 5: Access to the Website and to the Content – Restriction of access – Suspension or interruption of access**

##### **5.1. Access to the Website and to the Content**

The Website is accessible via the Internet network through a computer and/or a smartphone and/or a tablet computer. However, for a full optimisation of the Website, it is not recommended to access to it and/or to use it though a smartphone or a computer tablet.
